AWARDS:

Over \$5,000 in cash and prizes will be awarded including cash awards for “Best of Show”, “Best of Signature Members”, and “Best of Artist Members”.

ELIGIBILITY:

Open to all members of Plein Air Painters of New Mexico working in two dimensional media excluding photography and digital art. Membership for 2015 must be current and paid.

- PAPNM Artist Members may each submit up to three original works for entry jury consideration. A maximum of ONE of those works may be accepted for inclusion in the exhibition.
- PAPNM Signature Members and Master Signature Members are each invited to enter ONE original work for inclusion in the exhibition without being subject to the entry jury process.
- All work must be at least 80% completed **en plein air** within the past two years.
- All work must be original.
- Submitted work must **not** have been shown previously in any PAPNM exhibition. This provision is **not** meant to exclude work previously included in PAPNM on-line contests.
- Each dimension (length and width) of any image including the frame shall not exceed 32". Works that exceed the maximum outside framed dimension of 32" in either length or height will not be hung.
- Work done under the guidance of an instructor is not eligible.
- All work must be for sale. Artist will receive 60% of the sale price of the work.
- Another painting cannot be substituted for the painting approved by the jury.

ENTRY/PARTICIPATION FEE:

Artist Members - \$50 (Non-refundable) for up to three submissions, maximum one accepted.

Signature Members - \$50 (Non-refundable) for one submission.

Master Signature Members – no fee for one submission.

Entry fee may be paid online by credit card or by check mailed to: **PAPNM Treasurer, 130 Cougar Rd, Carlsbad, NM 88220** to be received no later than July 30th, 2015.

HOW TO ENTER:

Visit the website <http://www.callforentry.org> and login or open a new account. Follow the instructions to upload images to your Portfolio and Apply to Calls. Enter keyword **"PAPNM"** and you will arrive at the event application.

DIGITAL IMAGE GUIDELINES: Jpeg only, at least **1920 pixels** on the longest side, **72 dpi**, and **5mb maximum** per image. For further guidance on CAFÉ visit the CAFÉ HELP tab at the top of the website.

Notification of acceptance will be sent by email on August 31st.

FRAMING REQUIREMENTS:

- 32" x 32" is the maximum outside **framed** dimension.
- Accepted work must be sturdily framed and ready to hang with D-rings and wire.
- Gallery-wrapped canvases will be accepted if appropriate for the painting.
- No saw-tooth hangers will be accepted.

SHIPPING AND DELIVERY:

Complete shipping and delivery information will be included with notification to accepted artists.
